### **Board of Directors Meeting**

### Minutes of February 13, 2025

Jon Lux, Chairman, called the regular meeting of the Williamson Central Appraisal District Board of Directors to order Thursday, February 13, 2025, at 9:03 a.m. Board members present; Jon Lux, Hope Hisle-Piper, Michael Wei, Lisa Birkman, and Larry Gaddes. Lora Weber, Harry Gibbs, Mason Moses, and Mike Sanders were absent. Quorum declared.

Some of the District's management staff were in attendance.

Pledges of Allegiance

Receipt of Public Comments

There were no public comments.

Taxpayer Liaison Officer's Report

Report on Property Owner Contacts

Glenda Williams, the District's Taxpayer Liaison Officer (TLO), was present to report on the status of her contact with property owners.

Williams discussed a call received pertaining to a property owner's appraisal notice. She explained the appraisal notice process and reviewed the deadlines to file for the 2025 year. Discussion followed.

Williams expressed her appreciation to the District for their creation of a webpage for agents.

### Consent / Possible Action Items

The consent agenda includes non-controversial and routine items that the Board may act on with one single vote. Any Board member may pull any item from the consent agenda in order that the Board discuss and act upon it individually as part of the regular agenda.

### Consent Agenda Items:

Approval of Minutes of the Board of Directors for the regular meeting – January 9, 2025

Monthly Financials

**Quarterly Investment Report** 

**Quarterly Taxing Unit Payments** 

Gaddes moved for approval of the consent agenda items with the exception of the monthly financials report. Birkman seconded. The motion carried.

Lankford asked that the monthly financials item be pulled from the consent agenda for discussion. He pointed out that the litigation category had been overspent. Discussion followed pertaining to possible help with this issue.

The monthly financials report was filed for the audit.

### Subcommittee Report: General Meeting Guidelines

Birkman, one member of the General Meeting Guidelines subcommittee, reported that she had surveyed the entities regarding their meeting rules. She indicated that most have rules for the public, not for the Board members. Discussion followed.

Lankford mentioned that Robert's Rules pamphlets had been acquired for each member to have for review at Board meetings in the future. He indicated that these rules currently were not addressed in the Board's policy. Discussion followed.

The subcommittee, made up of Birkman, Hisle-Piper and Gibbs, was asked to bring its recommendation back to the full Board.

### **Annual Review of Contracts**

Lankford discussed the District's list of current contracts which are brought to the Board annually. He pointed out the contract descriptions which were previously requested by Wei and mentioned that all contracts are presented to the Board.

No motion was necessary.

### Chief Appraiser's Report

### Legislative Updates

Lankford provided updates regarding some legislation that could affect the District; he mentioned that it was very early in the process.

Among the bills discussed was Senate Bill 974. This bill would allow teachers to serve on the Appraisal Review Board. Lankford also mentioned Senate Bill 973, which would allow the District to post aerial photographs and street level imagery of properties on its website. Discussion followed.

House Bill 2550 was discussed. This bill creates a 10-hour training course for Board members. This training would be conducted by the Comptroller's office and would be available for free on their website with a minimal fee to purchase the completion certificate. Discussion followed.

Lankford announced that a bill had been introduced requiring an annual reappraisal of property. He also reviewed the changes that would occur if the Omnibus bill, HB 2432, were to pass. He mentioned a few of the items contained within this bill. The bill would require all appraisers to obtain a fee appraiser license which would be extremely costly. Discussion followed.

### **Exemption Update**

Lankford announced that the water treatment plant at Samsung had filed for exemption which had not been approved or denied yet. The District's attorney firm is in the process of reviewing the documentation provided for qualification. Lankford also indicated that when he has additional information pertaining to large developments, he would bring these to the Board.

### Notice of Appraised Value Review

Lankford displayed a copy of this year's appraisal notice. He mentioned that there were only minor wording changes from the prior year. These notices will be mailed on March 31st. Discussion followed.

### Property Value Study

Lankford reminded the Board that the Comptroller's office audits the District's property values every other year. He mentioned that the Property Value Study (PVS) results had recently been received and the district has passed the study for all school districts. He applauded staff for their work in passing the PVS.

### WCAD Entity Meeting

Lankford announced that the 2025 Entity Meeting was scheduled to take place on April 2<sup>nd</sup>. He indicated that an offsite location was discussed. Gaddes mentioned some possible locations.

Lankford announced that this year's materials would be provided electronically. He mentioned that the District would be posting the value reports on its website following the meeting. Lankford expressed his appreciation to Bart Edsell, an employee of the District, who had done an excellent job of putting this together.

### Family Events for Employees and Board Members

Lankford discussed the Employee Recognition Committee (ERC). Public funds cannot be used to acknowledge employee and Board member life events such as family weddings, births, and deaths. The ERC raises funds to provide these recognitions and invites Board members to participate if they desire. Lankford displayed a graph showing the funds and how they have been used.

### Lawsuit, Arbitration and SOAH Reports

Lankford reviewed the lawsuit, arbitration, limited binding arbitration and State Offices of Administrative Hearings (SOAH) reports. Discussion followed. Lankford explained the limited binding arbitration process.

### Board Agenda Additions for Future Meeting

 Lankford asked that Board members review the attributes of their property located in Williamson County. He announced that the values showing on these cards were not finalized. He indicated that the District requests this information annually from the Board and staff members. He asked that members review these cards by the next Board Meeting.
